#### How were the challenges met?

- Governors ensured well-being considerations were examined and supported
- Rigorous challenge and oversight of pupil progress
- Pro-active meticulous financial tracking, reporting and analysis. Investment in ensuring areas where possible financial benefit can be achieved are examined
- Autumn 2022 was spent recruiting parent governors and a staff governor
- Spring 2023 was spent recruiting a new Headteacher and then a new Deputy Headteacher

- Attending meetings and particularly for those held at the school, provides the governors with a better
  understanding of the challenges and needs of the school and also allows them to become more visible
