The Core Functions of The Governing Body


This governing body also can have Associate Members. Associate Members are not governors, but they are public volunteers. They are appointed by the governing body to support the ongoing work and duties of the governing body.



Governing Body Effectiveness and Impact

What were the significant challenges for the governing body in 2023/24

- Limited flexibility within the school budget
- Ensuring appropriate provisions are in place for children with SEND.
- Recruitment of co-opted governors.
- Ensuring there is a method to measure the impact of implementing Zones of Regulation to improve pupils' behaviour.


How were the challenges met?

- Pro-active meticulous financial tracking, reporting and analysis. Investment in ensuring areas where possible financial benefit can be achieved are examined
- More emphasis has been placed on communicating to parents the continuous improvements the school is making on SEND provision - generically and individual basis.
- Focus on recruiting volunteers to the governing body to ensure there is the right balance of diversity v required critical skill sets.
- Review of behaviour log, governors attending parents meeting (which included feedback from pupils) and regular updates with senior leaders. There is enthusiasm for the scheme from all parties. The behaviour log confirms the more serious instances of bad behaviour have decreased and teachers' feedback that children are willing and able to self-regulate their own behaviour.













What were the achievements of the governing body for 2023/24

- Good attendance from governors across all committees, meetings and training events.
- The governing body is strong in skillsets around financial management and education.
- Most meetings are held in the school, with governors performing walkthroughs and attending events.

How have these achievements improved areas of school life (impact)

- Significant effort is put into various meetings and full attendance allows the governing body access to substantial amount of information and detail. It also allows appreciation for the challenges and successes at the school. It also fosters trust amongst all attendees and aids with open and honest conversations – ensuring the children are at the centre of every decision taken.
- A diversified governing body ensures every perspective is considered. However, with a priority around improving the quality of education and having restrictive finances, it is very helpful to have governors with experience in these areas. It assists with ensuring the right informed decisions are taken by the governing body and senior leaders by drawing on experiences/knowledge held by these individuals.
- There is a preference for meetings to be held at school and governors to attend appropriate events. It allows
 governors to experience the school whilst it is in progress. Walkthroughs have allowed governors to meet
 with other members of staff, have a greater understanding of the school and test governance in practice.
 This is then fed back at the appropriate committee or meeting and may result in further questions leading to
 future improvements.
